Brief Description of Undergraduate Courses Taught: (Course Title – Code: Description)

Drug information and evidence-based medicine (CLPH 503): This course explores the fundamental aspects of drug information. It is designed as an introductory course to teach the student the principles of drug information pertaining to retrieval, evaluation and communication skills. In addition, the course should help students not only to understand the types of drug information available but also what sources of information are appropriate to use in a variety of situations.

Self-care and over the counter medications (CLPH 511): The purpose of this course is to familiarize pharmacy college students with available non-prescription drug products through: interactive discussions, writing assignments, and group presentations. At the conclusion of the semester, the student will be able to describe how a product becomes available over-the-counter, identify common active ingredients and products used in popular over-the-counter products, identify over-the-counter ingredients that are commonly abused, and analyze advertising used to promote over-the-counter products to the general consumer. Article readings may be assigned and should be read prior to the designated class period. The class session format will be a brief review of the topic with interactive discussion on the topic.

Research methodology and graduation projects (CLPH 507): this course provides students with an overview of the variety of research methods used in health research and the skills to determine which research method/s best answer/s their research question. Research challenges, including appropriate selection of design, research participants, sample size, data collection, and selection of appropriate measures, data analysis and interpretation of results are studied. It encompasses the understanding of presentation, analysis, interpretation of collected data. It presents an overview of basic uses of descriptive and inferential statistical methods. Students will have opportunities to advance their understanding of data analysis methods required to interpret data collected during the course of the proposed research.

Pharmacy ethics and law (CLPH 501): An applied analysis of federal and Saudi FDA law and ethical standards in the practice of Pharmacy and Pharmaceutical Care

Communication skills (CLPH 411): This course is designed to develop and enhance students' communication skills (listening, questioning and presentation) that are essential for the implementation of pharmaceutical care. The course aims at providing students with tools and techniques for effective interpersonal communication.

Pharmacy orientation (CLPH 201): This course highlight the definition of pharmacy and its education as well as its subjects. In addition, it will discuss the different areas of pharmacy profession available for future pharmacists as well as the role of pharmacists in healthcare system. Moreover, it will cover the available health pharmaceutical organizations locally and globally.

Foundation of health care and pharmacy practice (PHCY 202): This course provides a comprehensive overview of pharmacy and its education process as well as its subjects from admissions to advanced training. In addition, students will explore the various aspects of the Saudi Arabian healthcare system, including its organization, structure, financing mechanisms, delivery models, and regulatory frameworks.
