### Brief Description of Undergraduate Courses Taught: (Course Title - Code: Description)

- 1 Introduction to Public Health (PUBH 201-FLEC1449):. The central course question addressed is "What is the history and enterprise of public health?" The course explores population health, health equity, sustainability, climate change as well as the public health enterprise.
- Basic Biostatistics (HIMT315-CTFL; HIMT329-PTHF; HIMT329-RCRF; HIMT211-FI): It is a branch of applied statistics dealing with applications of statistical methods to problems in biology and medicine. It introduces basic statistical concepts for participants that include both descriptive and inferential statistics. Topics include an introduction to statistical distribution, hypothesis testing, and estimation. Computer-related statistical package (SPSS and or Minitab) is used to complete some exercises and problem solving for this course. Learning in the class will be facilitated through the use of textbook readings, class discussion, lectures, practical activities, pair and share activities, and oral presentation regarding the journal club.
- Health Education and Promotion (PUBH 214-FLEC): The aim of this course is to prepare students acquire the basic knowledge and principles of health education, health promotion concepts, frameworks, and the skills needed to advance students' career while helping people, communities and organizations adopt new lifestyle behaviors and assume an active role in improving health.
- 4 Principle of Epidemiology (PUBH225): This course focuses on the principles of epidemiology and provides an introduction to the fundamental knowledge and basic skills necessary for the practice of infection control and epidemiology. Topics include basic concepts, description and analysis of epidemiologic data, concepts of epidemiology in disease control, surveillance methodology, infectious process, infection control precautions and outbreak investigation.
- Applied Epidemiology (EPID 302-FLEC): The main goal of this course is to provide knowledge and skills necessary for the practice of epidemiological surveillance, investigation and epidemiological studies. Utilize epidemiological approaches to solve the public health problems, diseases prevention and control and community health promotion.
- Contemporary in Public Health (PUBH 406-FLEC): This course discusses updated, emerged and remerged public health issues in the field of global public health and Saudi Arabia in particular. Students will be able to understand the alternations and changes in this field including new problems, values, ethics, mission, and knowledge about how the public health functions today including the organization, financing, policies, control measures and management practices.
- Human Resources Management (HIMT 425-F01): This course is designed to introduce students to the field of Human Resource Management (HRM) within the context of healthcare. The main objective is to provide a solid foundation of knowledge of basic HRM topics. The course emphasizes a general management perspective of HRM. It examines HRM from the perspective of a manager who wishes to effectively interact with and utilize the human resource. The thrust of the course is on developing an understanding of HRM practices and assessment of their effectiveness. Topics include workforce planning, job analysis, recruitment, selection, performance appraisal & training and development, among others. Learning in the class will be

facilitated through the use of textbook readings, class discussion, lectures, cases-study analysis, journal club presentation, and application of Team-based learning.

- Graduation Project (PUBH 699-HCFL(7259) (for Public Health Department, 4th year): Students in this course required to select a topic for their project, define its objectives under the supervision of a faculty member, and then prepare a project proposal that includes: defining the problem to be addressed, collecting information on the proposed topic, making an exploratory preliminary study for the possibility of implementing the research proposal, writing the final research proposal -Create a schedule, and follow its content carefully. Work on implementing the requirements of the Research Ethics Committee, conducting the project, analyzing the statistical data, and then writing a report for the research project and the research results and making some recommendations.
- Graduation Project (HIMT424-F01; PUBH 413): In this course, students choose a project topic and define its objectives under the supervision of a faculty member, and then prepare a project proposal that includes: defining the problem to be addressed, collecting information on the proposed topic, making an exploratory preliminary study for the possibility of implementing the research proposal, writing the final research proposal -Create a schedule, and follow its content carefully. Work on implementing the requirements of the Research Ethics Committee, conducting the project, analyzing the statistical data, and then writing a report for the research project and the research results and making some recommendations.
- Learning skills (MSSH 106): It is a course dedicated to helping new students in the College of Applied Medical Sciences develop the skills that qualify them to achieve academic success in their field of specialization. By addressing effective reading and studying, self-learning, learning styles, study strategies, and giving them the opportunity to apply these mechanisms and strategies to other school subjects.
