Brief Description of Undergraduate Courses Taught: (Course Title – Code: Description)

1	Principles of Microeconomics ECON110 This course is designed to provide students with basic knowledge of the principles of economics which include the definition of economics, economic problem, the production possibilities curve, demand & supply and market equilibrium, the elasticities of demand and supply, consumer and producer equilibrium, production costs, the various forms of markets and conditions and the producer's equilibrium in these markets, and the demand for factors of production.
2	Principles of Macroeconomics ECON220 This course introduces concepts and theories in the field of macroeconomics. It develops student's ability to understand and estimate GDP and other national accounts. It also helps students in understanding the concept of macro equilibrium, economic cycles, unemployment, inflation, and economic policies (both monetary and fiscal policies).
3	Money and Banking ECON320 This course describes the international financial decision, the financial system and mechanisms of transmission of funds, policies of financial liberalization, privatization and factors of success or failure in privatization experiences in some countries. The course introduces foreign investment and forms. Further, it introduces theories of foreign exchange, international trade, methods of settlement, the role of the banking sector, balance of payments, and the risks of the internationalization of the business
4	Research Methods FIN313 The goal of this course is to introduce students to the most important aspects of scientific research, the use of sources of information, the characteristics of good research and researcher, steps for setting up research, scientific research methodology, samples and tools to gather information, data analysis, writing the final form of search, documenting the sources of information, and identifying sources of traditional and electronic information and their use in scientific research
