## The Decision To Reconstitute

the Excellence Committee

قرار إعادة تشكيل لجنة التميز  
(Administrative Decision)

- The President of Imam Abdul Rahman bin Faisal University.
- Based on the powers he has been authorized.
- After reviewing Article No. (50) of the regulations governing the affairs of Saudi university staff members, including faculty members and the like, regarding the description of the permanent committees and the determination of the reward to be paid to its members.
- After checking the recommendation of the Scientific Council in its seventeenth session for the academic year 1433/1434, dated 1434/17/07.
- After cognizing the distinguished minutes of the University Council in its seventh session for the academic year 1433/1434 on 1434/07/23, which includes the approval of the formation of the permanent committee to reward excellence for the members of the commission teaching and their judgment, approved by the Minister of Education and the President of the University Council under a letter by the Secretary-General of the Higher Education Council No. (1580) dated 1434/08/28.
- As a matter of public interest.

**First:** Formatting the permanent committee to reward excellence for faculty members, headed by the vice president of the University for Postgraduate Studies and Scientific Research and the membership of:

**Second:** It is assigned to carry out secretarial work and tasks for the coordination committee with the concerned faculties and follow-up with the work teams and the subcommittees each of :

- 1) Mr. Ahmed bin Abdullah Aldaig.
- 2) Ali bin Hussein Alshaqaaq.
- 3) Mohammed bin Salman Alboali

**Third:** The Committee takes all necessary measures to implement the regulations for disbursing the Excellence Award to Saudi faculty members in accordance with the criteria set out in the Honorable Council of Ministers Resolution No. (259) dated 14429/09/1, provided that its tasks include the following:

- 1) Suggesting executive controls and procedures mechanism.
- 2) Examining the requests referred to it by all faculties and departments of the university for the payment of an allowance for distinction.
- 3) Recommending all that is important in raising the efficiency of the allowance exchange controls and developing their procedures.
- 4) Studying all relevant topics that the President of the University or the Chairman of the Committee brings to it, and making appropriate recommendations.
- 5) Ensuring that the publication outlets for which publication qualifies for publication reward are within the publication vessels approved by the National Authority for Academic Accreditation and the Scientific Council at the university.
- 6) Ensuring that the patent submitted to reward excellence has proven its feasibility and benefits to humans.

**Fourth:** The committee members shall receive the remuneration prescribed by law for permanent committee members and meet at the time and place specified by the chairman of the committee.

**Fifth:** The committee has the right to form sub-committees and to seek the assistance of whomever it deems fit from the university sectors and its employees. All concerned parties must provide the committee with what is requested from it.

Sixthly: This decision should be enforced as of the date of its issuance, also it will be communicated to those who are required to legally enforce its obligation, and all previous decisions that contradict it shall be repealed.
